### Limited Warranty • Initials required

Parts provided by Dollens Auto Repair LLC will be warranted according to part manufacturers warranty. Parts provided by the customer will void this warranty in its entirety. Therefore, parts provided by customer voids the limited 90 day warranty of labor provided by Dollens Auto Repair LLC and the parts manufacturer warranty as determined by Dollens Auto Repair LLC.

## Deposits • Initials required
